

## Mission Viejo Swim & Racquet Club General Emergency Rules

The following Temporary MVSRC Facility Use Rules are intended to make using the MVSRC facilities accessible to the membership while promoting good hygiene and proper social distancing. Please understand that the risk of infection associated with COVID-19 is an unknown and, while MVSRC is taking precautions to minimize the risk, there is no way for the risk to be completely eliminated. Thus, please understand that **USE OF THIS FACILITY IS AT YOUR OWN RISK!** Also, please understand that MVSRC's ability to keep its facilities open and to mitigate the risk related to COVID-19 is dependent upon everyone working together with social distancing and doing their part to keep everyone as safe as possible.

1. Anyone using the MVSRC facility is required to adhere to all of the rules contained herein, **as well as all existing rules that do not conflict.**
  2. No person may access the MVSRC facility who is sick, who has a fever or a confirmed case of COVID19. Any person visiting a facility should wash their hands regularly and/or use sanitizer.
  3. MVSRC may be closed at any time, without notice. Residents are required to respect the instructions of all MVSRC staff relating to when the facility is open or closed, as well as any instructions pertaining to proper hygiene or social distancing.
  4. Any portion of the club facility that is closed (e.g., BBQ, Clubhouse, furnishings) may not be accessed or used at any time.
  5. All residents accessing the club facility are required to wear masks inside and bring either disposable sanitary wipes or similar cleaning materials to use on any surfaces in the facility that the resident intends to come into contact with (e.g. to disinfect a door handle before entry or to wipe down a chair). Residents are encouraged to wipe down furnishings both before and after each use as a courtesy to neighbors.
  6. Residents are required to maintain the minimum safe distance as currently required by the CDC between themselves and any other resident or group. Residents should be respectful of the sentiments of neighbors relating to social distancing.
  7. The furnishings available within MVSRC have been placed in a manner to promote proper social distancing. Residents may not move or rearrange any furnishings in a manner that interferes with social distancing or that encourages larger groups. Only one family may occupy any seating station regardless of whether there is additional space available.
  8. Access to the bathroom is restricted to one member at a time, and you are required to wipe down the area with sanitizing wipes that will be provided.
- Any person entering the MVSRC facility assumes any and all risks of illness or injury associated with his or her access to the club facility. Neither MVSRC nor any staff member is responsible for any illness or injury suffered by any person as a result of accessing the Mission Viejo Swim & Racquet Club.

# Mission Viejo Swim & Racquet Club Emergency Rules for Pool Use

April 21, 2021 Updated Rules

The following limitations will be in place for use of the Pool

1. Limited to 24 people per time slot. You must be a registered MVSRC member to use the pool.
2. Members are limited to 4 guests per household.
3. Jacuzzi is **limited to 3 people OR members of the same household**. Please be courteous of other people wanting to use the spa, and always maintain the recommended 6 feet of separation.
4. Times are reserved in hour and a half time slots and must be reserved through the office. You can reserve a space same day or up to 24 hours in advance, space permitting.
5. Must maintain 6 feet of separation.
6. Sunbathing is allowed, only during the time of your reservation, you will need to maintain the 6 feet of separation and a **face covering is recommended** when outside of the water. PLEASE DO NOT MOVE THE LOUNGERS.
7. BBQs are now available. Please do not gather with people outside of your household and please be aware of others wanting to use the BBQs.
8. A pool reservation must be made to use the BBQs at this time.
9. There is no glass permitted anywhere near the pool or in the pool area.
10. Bring your own water, water fountains will not be in use.
11. No re-entry. Please come prepared to use the pool, towel, sunscreen, swimmers if needed. Once you are in the pool area, there will be no re-entry because you forgot something.
12. There are no lifeguards on duty, no one under 14 will be allowed without a parent, anyone 14 and over must have a swim card on file to come without a parent/guardian.
13. You must adhere to all existing pool rules that are already in place, including the emergency rules.
14. Bathrooms are available. Please wipe down all surfaces with the sanitizing wipes that are provided.
15. There is no eating or drinking (other than water) in the pool area. Please do not congregate or gather with people outside of your household.
16. When you are done swimming, or sunbathing, please exit the pool area, even if your swim reservation is not up.
17. Face coverings are recommended when you are outside of the pool.
18. You must adhere to all existing pool/jacuzzi rules that are already in place, including the emergency rules.
19. You are using this facility at your own risk. While we are doing everything to minimize the spread of Covid19, transmission may still be possible.
20. If the city, county, or state determine we must close again, this will be implemented immediately.

## **Tennis Courts Mission Viejo Swim & Racquet Club Emergency Rules**

### **April 21, 2021 Updated Rules**

1. The tennis courts are available for single and double players, as well as individual private and group lessons with MVSRC Tennis Pro.
2. Times are reserved in hour and a half time slots and must be reserved through the office. You can reserve a space same day or up to 24 hours in advance, space permitting.
3. Must maintain 6 feet of separation.
4. Bathrooms are not available.
5. Please bring your own hand sanitizer and wipe down the gate upon entering and exiting. Once you are on the court, there will be no re-entering, please be prepared to play only for your allotted time. Some sanitizing wipes and or hand sanitizer will be provided, but these are in short supply.
6. You must adhere to all existing tennis court rules that are already in place, including the emergency rules.
7. Please no congregating on the benches or in the parking lot.
8. Please be courteous of other players who are scheduled to play on the court after your reservation is completed. Be prepared and ready to leave a few minutes early so you are not passing other people coming in to play.
9. Bring your own water, water fountains will not be in use.
10. If the city, county, or state determine we must close again, this will be implemented immediately.

## Mission Viejo Swim & Racquet Club Emergency Rules for Gym Use

April 21, 2021, 2021 Updated Rules

Members must sign the [Fitness Center Usage Waiver](#)

The following limitations will be in place for use of the Gym

1. Times are reserved in hour time slots and must be reserved through the office. You can reserve a spot same day or up to 24 hours in advance, space permitting.
2. Only **ONE** person will be permitted in the gym at a time, **OR** members from the **same** household.
3. **NO GUESTS WILL BE PERMITTED.** You must be a registered Club member to use the gym.
4. A face covering is **REQUIRED** while entering and using the gym, **this is for our safety and yours.**
5. Bathrooms and kitchen are not available. Please adhere to this rule as the bathrooms and kitchen are for **STAFF USE ONLY, this is for our safety and yours.**
6. Please use the hand sanitizer when entering the gym and leaving the gym. There is a dispenser on the wall next to the light switch.
7. You are responsible for cleaning/wiping down all the equipment that you use.
8. Bring your own water, water dispenser will not be in use.
9. The waiver to use the gym must be signed and kept on file in the office.
10. **USE AT YOUR OWN RISK.**
11. You must adhere to all existing gym rules that are already in place, including the emergency rules.
12. If the city, county, or state determine we must close again, this will be implemented immediately.
