

POOL RULES

Pool Occupancy: 100 PROPER ID IS REQUIRED TO USE FACILITY

- 1. Children under 7 MUST be accompanied by an adult.
- 2. Children 7-13, with proper ID are allowed to swim when lifeguards are on duty ONLY.
- 3. Teens 14 and 15 who are members of MVSRC, with a photo id on file, are allowed to use pool and spa without lifeguards on duty but are not permitted to bring outside guests when lifeguards are *not* on duty.
- 4. NO one under 14 allowed in spa without adult supervision.
- 5. No running, playing chicken, flips of any kind or horseplay allowed in pool area.
- 6. No Boogie Boards, squirt guns of any type, No Balls of any kind, ie; tennis balls, water balls, footballs, soccer ball or water polo balls, beach balls allowed in pool area.
- 7. Noodles are allowed unless a lifeguard requests they be removed.
- 8. No glass of any kind allowed in or around pool or spa area.
- 9. No FOOD, GUM or DRINKS allowed in or next to the pool/spa's edge.
- 10. Swimmers must wear bathing suits. NO street attire allowed in pool.
- 11. Any person who is incontinent or not fully potty trained must wear appropriate waterproof clothing when entering or being carried into the pool. We do not permit babies or toddlers to enter pool without clothing.
- 12. Members MUST stay with their guests at all times. *No Drop offs*.
- 13. Homeowner's are limited to 6 guests per household per day to the pool area. All guest's names must be left with the office staff.
- 14. Individuals with skin disorders, communicable diseases or open wounds are NOT allowed in pool or spa.
- 15. When necessary, Club personnel have the authority and the responsibility to take necessary disciplinary measures with all age groups with regards to the use of the facility.
- 16. Individuals who create a problem will be asked to leave the premises. If the individual refuses, the local authorities will be called for assistance.
- 17. Management and Lifeguards reserve the right to ask for proof of membership of the Mission Viejo Swim & Racquet Club at any time. Persons may be asked to leave if unable to provide proper id regardless of homeownership.
- 18. No pets allowed in pool area except working dogs, must show certification.
- 19. The Club is not responsible for lost, stolen, or damaged articles
- 20. Personal music is permitted with earbuds. Wifi is available, see office personnel.
- 21. When break time is called by the lifeguard NO children under 14 years of age with or without an adult are permitted in the pool during this time. Children are required to stay **behind** the coping tiles.
- 22. Personal floatation devices, such as arm floats, swim rings, flotation vests are NOT permitted in the spa or past the 2-1/2 foot level unless the child is under direct supervision of an adult who is within arm's length of the child.
- 23. No smoking or Vaping allowed within 20 feet of any entry of facility.
- 24. Persons having currently active diarrhea or who have had active diarrhea within the previous fourteen (14) days shall not be allowed to enter the pool water.

NOTICE: Club members and guests are expected to follow all rules and lifeguard instructions. Immediate problems in the pool area, concerning the use of the pool shall rest with the manager or the lifeguard on duty. Decisions will be made in the interest and welfare of all members. In case of an emergency, the pool will be cleared until normal operation is possible.
